For late submission of the application 25% of the scheduled licence fee shall be paid in addition.

Note: For calculating the maximum number of workers to be employed on any day during the year the total number of workers (in all shifts) employed on that day and the workers employed through all agencies also included in this total shall be taken.

(2) All fees shall be deposited under the following head of account. **"0230-Labour and Employment". 104 Receipts is under the Factories Act, 1948** Care shall be taken to reproduce this head correctly on all challan forms and that the seal of the Treasury or the Bank is legibly affixed.

(3) The fee for obtaining a duplicate copy or for effecting any amendment therein is as prescribed in the Rules.
